### 15 Description of Equipment or Protective System

A NEXLED Luminaire comprises a cast aluminium flat rectangular base and a cover with a glass diffuser. The diffuser is attached to the cover with two screw clips and the cover is attached to the base with four screws. Ingress protection is provided with a silicone rubber gasket between the base and the diffuser.

The internal arrangement comprises up to eight 1W light emitting diodes mounted onto an aluminium heatsink or two LED's without a heatsink, an electronic control module and fuse within a cylindrical flameproof enclosure, and terminal strips.

The luminaire is rated up to 254V a.c 2W to 8W depending upon the number of LED's fitted.

The enclosure is provided with cable entry holes which must be fitted with ATEX EEx e approved cable glands which maintain the ingress protection of the enclosure. Unused entries must be fitted with ATEX EEx e approved stopping plugs.

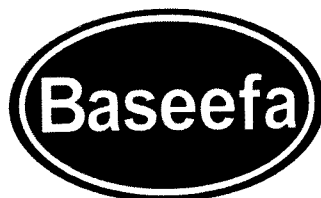

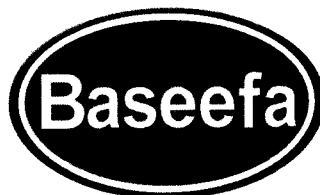


