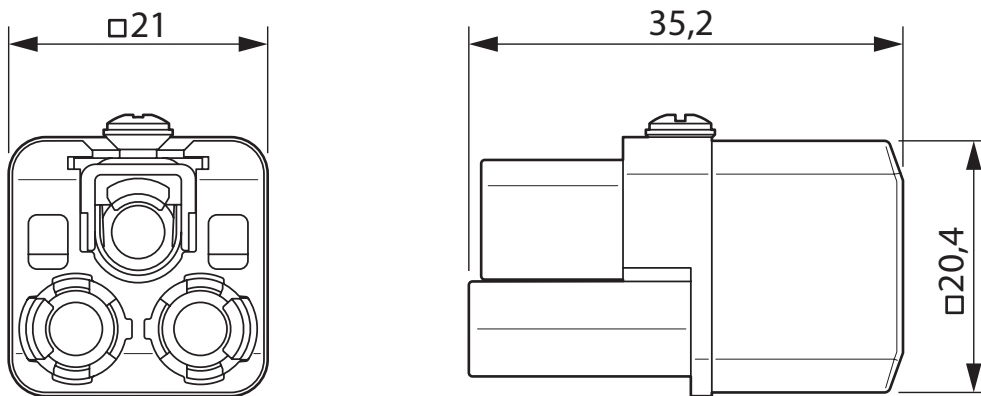

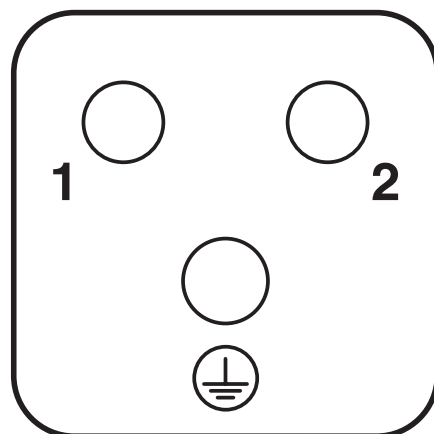

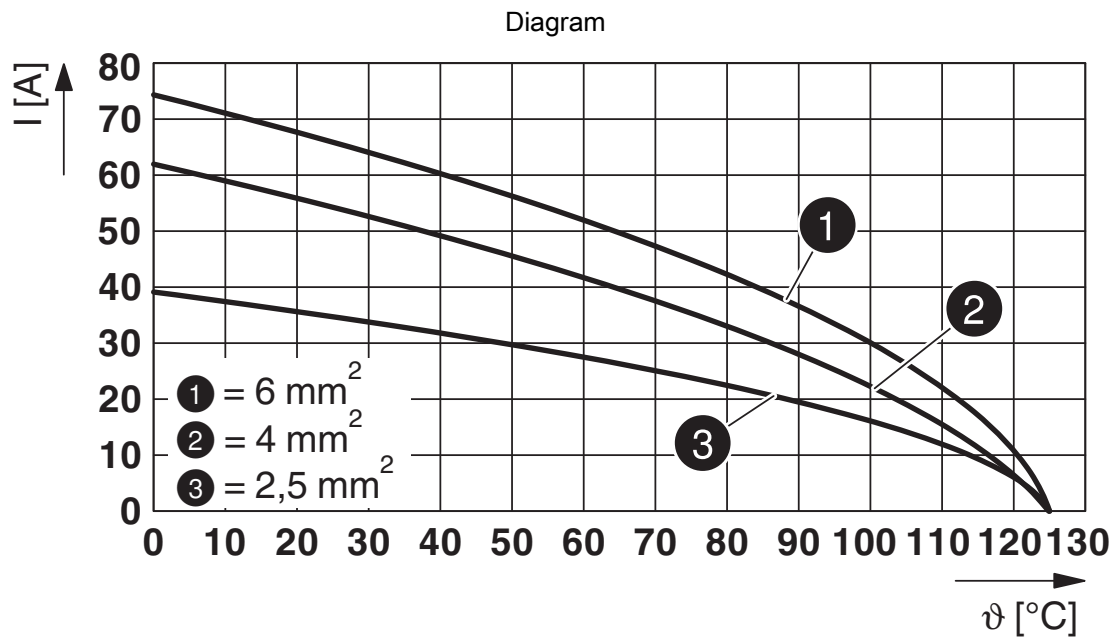
Schematic diagram
